ORDER (DISCONTINUANCE AND COSTS)

THIS MOTION, for Orders (i) discontinuing all claims between the plaintiffs and the defendants that have not been resolved by way of a settlement agreement; and (ii) approving the fees and disbursements of Class Counsel, was heard this day at the court house, 330 University Avenue, 8th Floor, Toronto ON M5G 1R7.

ON READING the affidavit of Michael Gerhard, sworn June 9, 2022, the settlement agreement between the plaintiffs and the defendants, Old Republic Insurance Company of Canada

("Old Republic") and WorldStrides Canada, Inc. ("WorldStrides") (the "Settlement Agreement") related to the Old Republic Insured Trips (as defined in the Settlement Agreement), and the motion records filed by WorldStrides and Arch Insurance Canada Ltd.; and on hearing the submissions of the lawyer for the plaintiffs,

AND ON BEING ADVISED that the defendants consent to the order discontinuing all claims between the plaintiffs and the defendants that have not been resolved by way of a settlement agreement and that the defendants take no position on the motion to approve the fees and disbursements of Class Counsel,

- 1. **THIS COURT ORDERS** that, in addition to the definitions used elsewhere in this Order, for the purposes of this Order, the definitions set out in the Settlement Agreement apply to, and are incorporated into, this Order.
- 2. **THIS COURT ORDERS** that the plaintiffs' claims that are not resolved by way of the Settlement Agreement be and are hereby discontinued, without costs.
- 3. **THIS COURT ORDERS** that CV- 20-00649430-00CP (*Carter Adnams, by his litigation guardian, Scott Adnams v. Arch Insurance Canada Ltd.*) be and hereby is discontinued, without costs.
- 4. **THIS COURT ORDERS** that a copy of this Order shall be (i) e-mailed to all class members who have registered for information in respect of this claim with any of Adair Goldblatt Bieber LLP, Sotos LLP, Curtis Dawe Lawyers, and Samfiru Tumarkin LLP; (ii) posted on the Websites of Sotos LLP and Samfiru Tumarkin LLP for at least 60 days from the date of this Order; and (iii) posted on any Facebook pages associated with this litigation.

- 5. **THIS COURT ORDERS** that legal fees and disbursements totalling \$300,000, all inclusive, are awarded to Class Counsel to be paid by Worldstrides and/or Old Republic, in accordance with the Settlement Agreement and shall be paid to Sotos LLP, in trust, on behalf of Class Counsel within 7 days of the date of this Order.
- 6. **THIS COURT ORDERS** that the Class Counsel fees and disbursements totalling \$135,000, inclusive, are awarded to Class Counsel to be paid by Worldstrides, and shall be paid to Sotos LLP, in trust, on behalf of Class Counsel within 30 days of the date of this Order.

THIS ORDER BEARS INTEREST at the rate of 2.0 percent per year commencing on July 29, 2022.
